The organization was unaware the IRS had recently ceased accepting paper filed returns, and would henceforth accept only an electronically filed return. The organization only learned of the new requirement when they received an IRS notice dated January 3, 2023, which was also accompanied by the originally filed return. Upon receipt of the notice, the organization promptly arranged for the Form 990-EZ return to be prepared for electronic submission.</p> <p>The organization respectfully requests the Service accept this return as timely filed, and further requests any potential late-filing penalties be abated. The Service's consideration is appreciated.</p>
